Subject: Report on crimes of unlawful displacement, looting, vandalism, arson-attack and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of Dopkon Village, P.O., P.S. & district- Churachandpur, Manipur.

That, on the 3rd of May, 2023 at around 7:30 PM, a mob of armed Meitei/ Meitei suspected to be members of Arambai Tengool, Meitei Lleepun along with the Manipur Police Commando(Bishnupur) and the Meitei/Meitei' in and around the area, attacked our village, in the process they have looted all my household items/ movable assets arson-attack and vandalized my house.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.52,75,000 (*Rupees Fifty-Two Lakhs Seventy-Five Thousand*) Only, inclusive of the house and the household items / movable assets, that includes;

3)Furnitures	Rs.3,00,000/-
4) Electronics & electricals	Rs.1,00,000/-
