I the undersigned would like to state that, I have
a stall in Rajesh Hotel inside the campus of Mini-seel
Tribong, and my residence is located at infront of DC
Phozang office Main-gate (near GAR). That on the latest
night of 15th February 2024, I was stuck at Mini-seel
Tribong because of the clash between security forces and
civilian. I was stuck at Mini-seel Tribong for 02 (two) days
and during that time, my residence was attacked, looted
and vandalised by some unknown miscreants, by breaking
through the back door of my house. The looted items
include Jewellery, 02 cylinder gas, household items, clothes
and a cash of Rs. 80,000/-

I would like to request your good office to help
us in recovering the looted items and in capturing the culprit
and give benefitted punishment as per the law.
