The said Khawvaiphei Village mentioned herein above is bordering Torbung Meetei residential area, subsequently due to which since the 3<sup>rd</sup> of May, 2023 me and my family had to desert the said village since it is situated adjacent to Meetei Locality and prone to attack by armed radicalized groups belonging to the Meetei Community, and had been taking refuge at Vaal Veng New Lamka, Churachandpur, Manipur-795128 since.

That, on the 18th of December, 2023 after the situation presumably returned to normalcy we went to check in on our house and were shock to find that the said house had been ransacked, looted and vandalized by an unknown miscreant, a total loss approximating to be at an amount of Rs. 12,50,000/- worth of my personnel property was lost due to the said incident.

There is no denying the fact that, there has been some delayed in filing of this FIR, however due to the mental stress and agony aiding to my old age such was the reason, I thereby, request you to kindly registered this FIR and book the culprit as per the prevailing provision of the Law of the Land.
