With reference to the subject cited above, this is to inform you that site outage alarm was received in our system at the site id-UMP101 (site address Lamthenlal Kipgen, S/O- Lhunkhomang Kipgen, Vill-Bungkot,PO- Churachandpur,PS-Henglep, Dist-Churachandpur, State- Manipur, Pin- 795128, Mob-9366428217) on 11-06-2024. It was found that some unknown miscreants had barged into the tower site and stolen away the network equipment after having broken the cabinet lock and removed from the tower with an ulterior motive of monetary gain also disrupting the communication.

Frequent unabated thefts of these kinds of equipment from our tower sites have impacted the very communication network though replacements of the equipment subject to the availability is made immediately to maintain network. It is to be mentioned here that because of huge number of thefts taking place in the circle, we are running short of such shock of equipment for replacement.

In view of above, I request you to kindly register a case in this regards and investigate the same to bring the culprits to book and recover the stolen items at your earliest possible.

Due to the ongoing conflict in Manipur we weren't able to file the complaint timely as our site engineer were not able to reached the site, prayer for your kind consideration for accepting our complaint please.
