

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of Lailampat Village, P.O., P.S. & district- Churachandpur, Manipur.

That, on the *4th of May, 2023* at around *6:00 PM*, a mob of armed Meetei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with the Manipur Police Commando(Bishnupur) and the Meetei/Meitei' in and around the area, attacked our village, in the process they have looted all my household items/ movable assets arson-attack and vandalized my house.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about *Rs.22,10,000 (Rupees Twenty-Two Lakhs Ten Thousand)* Only, inclusive of the house and the household items / movable assets, that includes; .

1) Residential House	Rs.15,00,000/-
2) Household items/assets	Rs.4,00,000/-
3) Electronics & electricals	Rs.60,000/-
4)Livestocks(Cows, Pigs, Chicken & Ducks)	Rs.1,50,000/-
5) Misc	Rs.1,00,000/-
TOTAL AMOUNT	Rs.22,10,000/-
