**Subject: Application for registration of FIR for Forgery for the Purpose of Harming the Reputation and Making a False Document**

Sir,

I am compelled to bring to your immediate notice for your swift action an urgent matter. That on March 16, 2024 at about 12:47PM a **WhatsApp Channel** namely **Lamka Media** (hosting 3.6k followers/subscribers) maliciously published and disseminated false information using the Zomi Students' Federation GHQ letterhead along with forged signatures of the President and Secretary of the Federation (**photocopy enclosed as Annexure - I**). That, the malicious and false information was also published by facebook handler named **S Chinlian Kap Kipping** in **India Zomi Platform** Facebook Group (hosting 6.1k members). (**photocopy enclosed as Annexure - II**). The malicious information not only tarnished the untainted reputation of the Federation (ZSF GHQ), it has the malicious intent of causing enmity between different communities within the district under your jurisdiction. Given the volatile situation of the State at this point in time it is of the utmost importance that such nuisance acts be dealt with immediately so that further mishap be brought to an end.

That, at around 1:11PM, the same WhatsApp channel posted a screenshot of the PR where it was tagged fake, with a remark that 'it is impossible to discern what is fake from what is not' (**Photocopy enclosed as Annexure III**), tacitly reinforcing their malicious post, while the negation of the authenticity of the post which the federation clarified to concerned public as false to be not true.

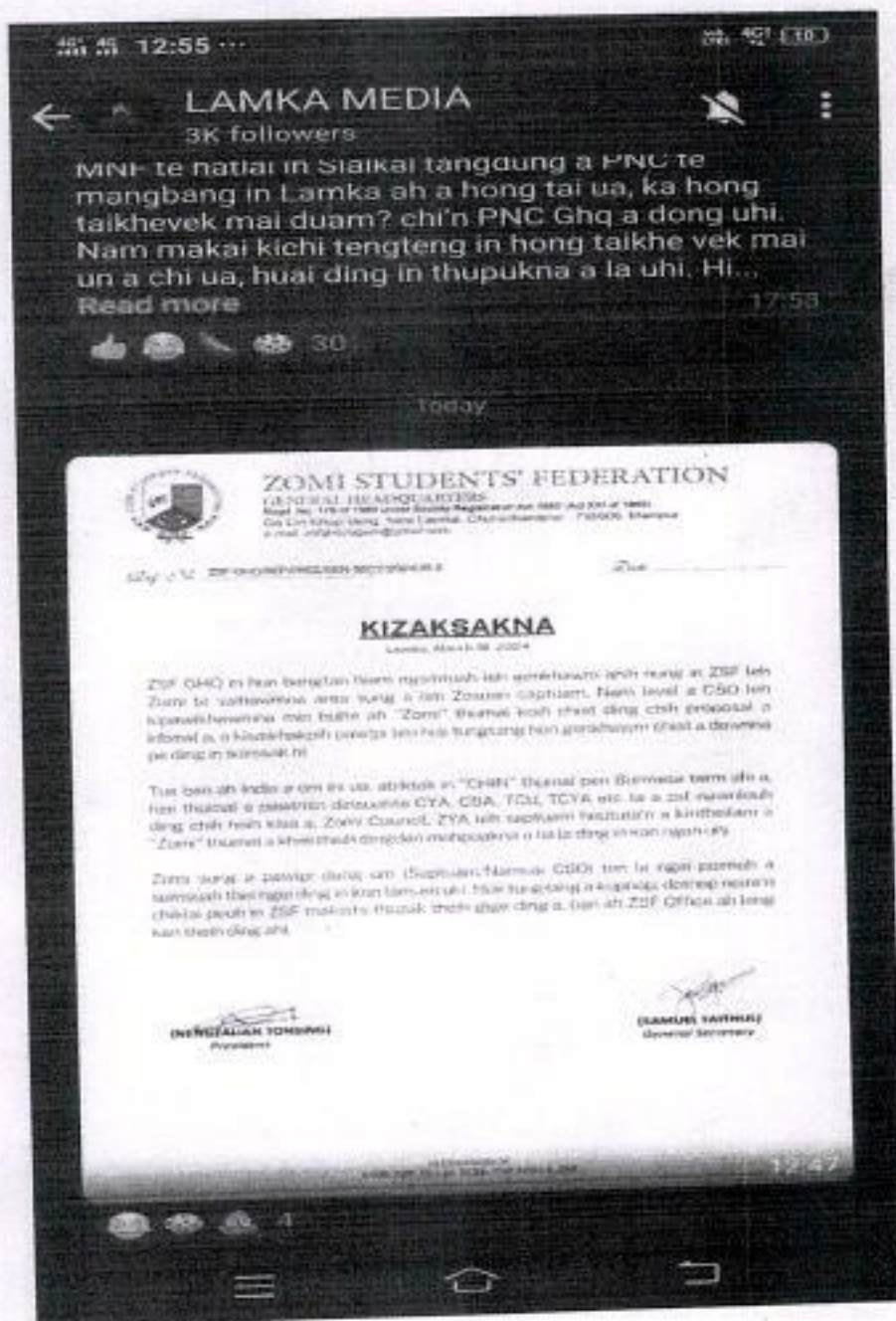

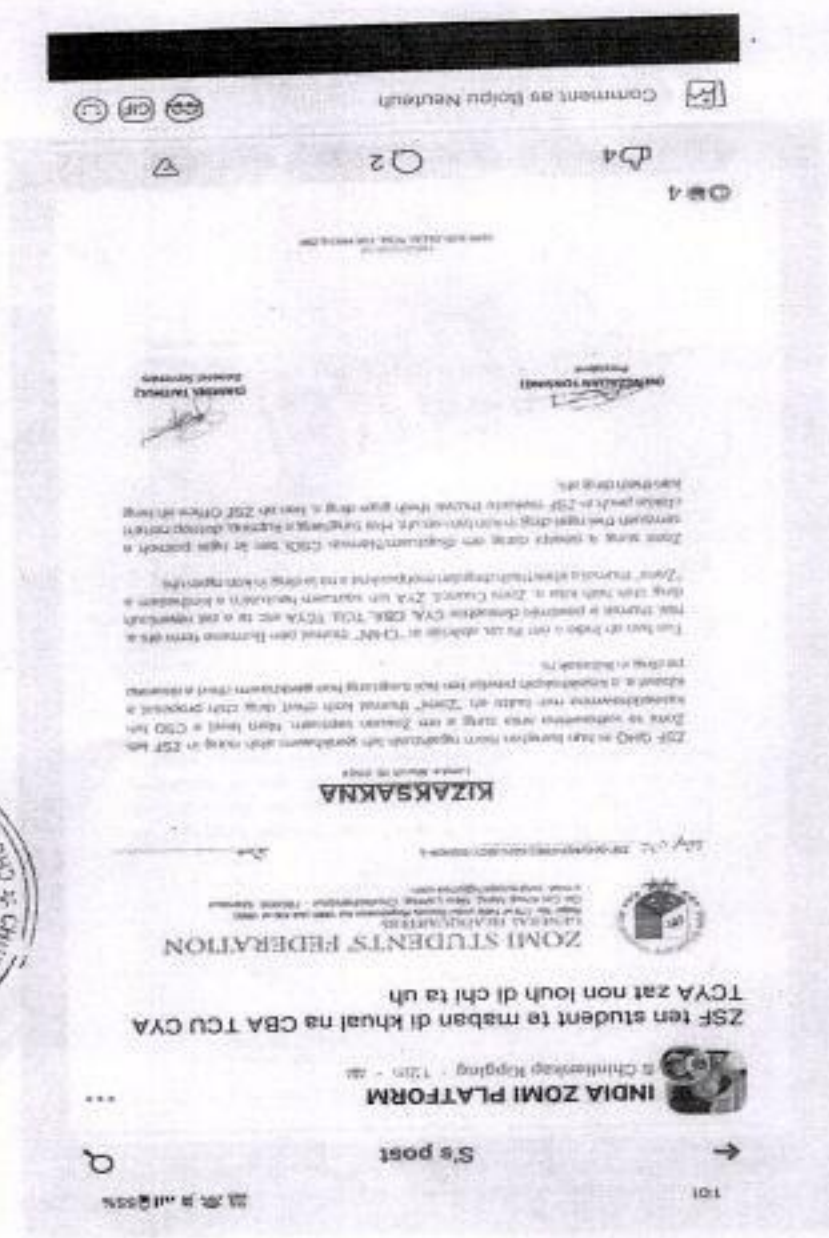
