Sub.: Report on crimes of attempt to murder, use of lethal weapon, pelting stones at innocent public.

Respected Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, on the night of the 17th of March, 2024 at around 9:50 PM, a group of unknown miscreants were travelling in a four-wheeler with an intent to commit an unlawful activity, on reaching the front-side of my residential house gate, they halted and fired(gun-shot) at my house, therefore, the said miscreants committed an act with an intention to kill or an attempt to kill me and the members of my family. And whereas, the said vehicle is suspected to be a white(colour) Hyundai Creta of SUV variant.

That, after the incident, the said criminals fled the scene towards Bungmual Village area. And on being alerted by the Gun-shot, my neighbour along with some members of the village started gathered in and around my house premises. Whilst, thinking the scene has ended for the day, 2(Two) persons on a motorcycle approached towards my residential house again, pelted stones at the said gathered innocent public and my house, which resulted in causing injury to a lady and a young child.

Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
