Subject: Application for registration of FIR for defaming the reputation of the Zomi Council Steering Committee (ZCSC), and for promoting enmity between different communities.

Sir,

It has come to our notice on March 18, 2024 that there is a video circulating in various social media platforms which portrays the Zomi Council Steering Committee (ZCSC) as a party to vandalism. The malicious video caption has fallaciously labeled the ZCSC to be in cohorts with two other organizations as instigators/supporters of the attack on the office of the Indigenous Tribal Leaders' Forum (ITLF) situated at the District Library, Hiangtam Lamka and residence of ITLF spokesperson at D. Phailien Village. That, the video could be still seen circulating in social media posted by one Facebook handler- *Ngambom Pa in KUKI DIH TAH KAH I E* facebook group. (Copy enclosed as Annexure - I)

The viral video with its defamatory caption/remarks had not only tainted the image of the ZCSC with malicious intent, falsely accusing the organization of a crime which it is not a party to, nor knows anything about, it has also promoted enmity between different communities within the police Jurisdiction of Churachandpur (Lamka) and beyond. The said libelous caption as seen in the video is nothing but a vicious ploy to paint the ZCSC in bad light and tarnish its reputation.

The ZCSC has been working in tandem with the public on humanitarian issues, relief, human rights and others for the benefit of all communities. Such accusations not only throw a defamatory remark on the organisation but have a potential to defame the whole Zomi community as a whole, as the organization is an apex steering committee for the Zomi Community of 9 (nine) conglomerate tribes.

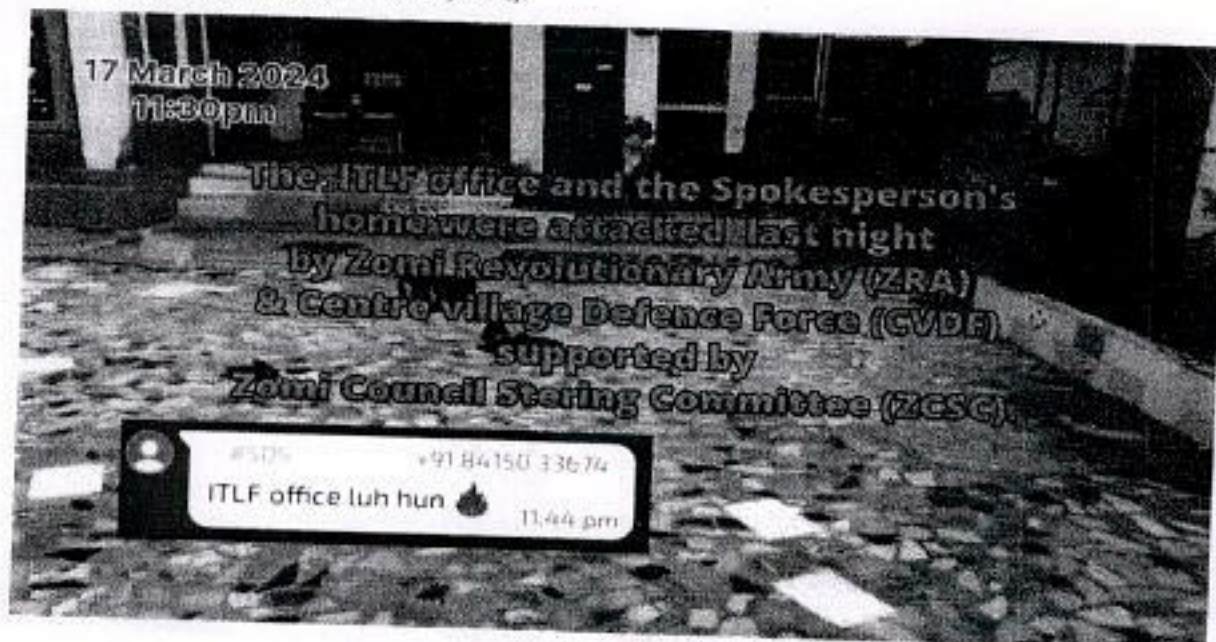

It maybe pertinent to note the similarities between the caption in the video and the caption/comment written by the Facebook handler Ngambom Pa in KUKI DIH TAH KAH E Facebook page, making one suspect if the said Facebook handler is the creator/editor of the video's caption:

1. The letter 'C' in CVDF stands for 'Central'; however, the video caption and Ngambom Pa's Facebook comment use the word 'Centre.'
2. The letter 'v' in village is both small letters in the video caption as well as Ngambom Pa's Facebook caption.
3. The word 'Steering' in Zomi Council Steering Committee is misspelt as 'Stering' in both the video caption as well as Ngambom Pa's Facebook comment.
4. The formatting and arrangement of the words in the video caption as well as Ngambom Pa's Facebook caption seem to look the same.
