

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Any Kuki Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of New Zalenphai Village, P.O., P.S. & district- Churachandpur, Manipur.

That, due to the ethnic crisis in the State of Manipur, a mob of Meetei/ Meitei warmongers suspected to be members of Arambai Tengool and the local in and around the area attacked our Torbung area, in the process they have torched/ burnt my two-wheeler, pakred near my Mother's rented Retail Shop owned by namely, **Gincha** on the 3rd of May, 2023 at around 5:40 PM located at Torbung Bazar, P.O., P.S. & District- Churachandpur, Manipur.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about **Rs.1,10,000/- (Rupees One Lakh Ten-Thousand)** Only, the details of the said vehicle are;

- 4) Regn. No. - A/F

The reason behind my late application is due to which I was with my family nursing my elder brother who was admitted at NIGRIMS Shillong, Meghalaya for months.

Therefore, I humbly pray you to kindly register an FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
