Subject: - Report for theft of mechanical parts from Workshop

Sir,

I have the honour to submit this report that I was running a Motor Workshop named "Body Workshop" at S. kotlen near Bangla under the Police Station of Churachandpur before the outbreak of the incident. On 03/05/2023, as the communal clash starts, I was informed to leave the workshop by the owner of the workshop namely Kailun Mang. As informed, I left my workshop leaving all motor parts behind for home at Terakhongsangbi Maning Leikai on the same date.

Later, I came to know that all the motor parts in the workshop had been stolen and damaged by a group of unknown Kuki miscreants as informed by the owner of the workshop via mobile phone on 10/05/2023 at about 11.20 am. However, I did not know when they had stolen and damaged the motor parts from the workshop which is the only means for my earning. But the theft could have been committed on the first week of May, 2023.

Delay in reporting to your good office is due to the fact that I was out of home for some months to earn money for my family.

It is, therefore, requested to kindly initiate a legal action against the unknown Kuki miscreants who stole and damage motor parts from my workshop please.


