Sir,

I have the honour to report that on 05/April /2023 my vehicle road roller bearing No.MN05/2806, Chassis No. Qty No-1 and Engine No. PIN001CM-RR-004 owner by my father namely Irengbam Shyamkeshor Singh s/o (L) I. Chandramani Singh of Tronglaobi Makha Leikai, P.O/P.S:- Moirang , Dist:- BPR, Manipur and one DI Tata (Pick-up) bearing regd. No. MN02/6488 , Chassis No. MAT374445JSB01691 , Engine No. 4SPCR10BRY606824 by were hired by one contractor Mr. Angam of Kuki tribe for road repairing (Pucca) work site located at Tuibong village , Churachandpur ,P.S:- CC Pur under Deputy commissioner-Churachandpur. Then, on 03/05/2023 started communal calashes between Kuki and meitei, my two driver came out from the work site to their residence for saving their lives and the said vehicles were kept in the safe custody of work site. In this matter, I collected source information from CC Pur side, that during the month of Dec. 2023 my roller vehicle and DI Tata (Pick-up) were stolen/looted by some unknown kuki militants or community from the said work site. The said roller vehicle is worth about Rs. 30,00000/- (thirty lakhs) apprx. and (DI Tata (Pick-up) is worth about 10,70,000/- (Ten lakhs seventy thousands) apprx. Total amount is Rs. 40,70,000/- (Fourty lakhs seventy thousands only) Apprx.

It is therefore, kindly look after the said vehicle in your respective P.S and take up further necessary action please agianst the said culprite.
