

#### Dear Sir.

With reference to the subject cited above, this is to inform you that site outage alarm was received in our system at the site id-UMP555 (site address Neitinkhawl Vaiphei, W/O- Soitinkhup Vaiphei, Vill-Thingkeu, PO- Henglep, PS-Henglep, Dist- Churachandpur, State- Manipur, Pin- 795128, Mob-8837429242) on 11-06-2024. It was found that some unknown miscreants had barged into the tower site and stolen away the network equipment after having broken the cabinet lock and removed from the tower with an ulterior motive of monetary gain also disrupting the communication.
