Sir,

1. It is to inform you that, Assam Rifles has been acquired land measuring 100 acres at Songpi Village at Churachandpur, District Manipur for establishment of Key Location Plan (KLP) of one Sector Headquarters and one Assam Rifles Battalion from Mr Zamlianlal Haokip. The land was under litigation from 11 Sep 2017 to 10 Jan 2023 and a Judgment order passed by Hon'ble High Court Imphal dt 10 Jan 2023 to hand over the land to Assam Rifles at the earliest. Further on accordance to above judgement an order Deputy Commissioner/Collector (LA), Churachandpur was circulated for joint demarcation of land vide their letter No 3/62/2020-DG/CCP dt 06 Feb 2023 (in this regard Sketch of Songpi Land attached)

2. Further to above order, the demarcation was carried out in the presence of ADC, Churachandpur, SDO, Churachandpur, Staff from Land Revenue Department, Land Owner and Assam Rifles representatives on 09 Feb 2023 and demarcation process of the same was completed on 11 Feb 2023. After completion, the land was handed over to Assam Rifles executing a Regd Deed No 03AA 595710 to 03AA 595714 dt 24 Jun 2023 (Copy attached).

3. Subsequently, to ensure security of land and prevent encroachment the boundary was demarcated with long iron picket chained with iron barbed wire as per land boundary. Regular area domination patrol were also carried out to ensure the security of the land.

4. I would like to bring to your kind attention during the monthly inspection of land carried out by this unit on 01 Apr 2024, it was found that 98 Nos long iron picket and 22 Nos Barbed wire (01 Roll 50 Kg) has been uprooted by unknown miscreant from the location. It is suspected that the said items has been stolen from the site, which will likely increases the threat of encroachment of own land.

5. In view of above you are requested to lodge a FIR against unknown miscreant who have stolen the 98 Nos long iron picket and 22 Nos Barbed wire (01 Roll 50 Kg) at your police station at the earliest and to instruct village authorities and locals residing in the locality of the said land not to encroach or allow any encroachment of the land.

6. Your kind co-operation an early action on the subject will be highly appreciated.

This deed of handing and taking over of land is executed on this 24th day of June, 2023 between the Deputy Commissioner/Collector (Land Acquisition), Churachandpur hereinafter called the First Party AND the Assam Rifles represented by HQ. 27 Sector Assam Rifles, Tulbong and 36 Assam Rifles, HQ. Veng hereinafter called the Second Party with regards to acquisition of 100 acres of land situated at Songpi village, Churachandpur for establishment of Key Location Plan (KLP) of Sector Headquarters and one Assam Rifles battalion.

Whereas, the Commissioner (Revenue), Government of Manipur vide No. 4/4/LA/2013-Com (Pev) dated 10.05.2017 issued preliminary notification under section 11(1) read with Section 40(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 hereinafter after called the Act stating that the land measuring 100 acres of land (land schedule given below) was likely to be needed urgently for a public purpose i.e. construction of Key Location Plan (KLP) of Sector Headquarters and one Assam Rifles battalion at Songpi village, Churachandpur, District for maintenance of law and order and national security;

Haokip of Songpi village and no other persons are affected except the land owner and hence rehabilitation and resettlement scheme not applicable in the proposed land acquisition. Further, no public utilities, government buildings and infrastructural facilities exist and no objections were received from any interested persons to the proposed land acquisition;

Handwritten notes: Whereas, the First Party i.e. Collector (LA) vide letter No. DC(CCP)/LA-SONGPI/2013-37 dated 21.08.2017, submitted the First Schedule under section 30(2) of the Act of 2013 amounting to Rs. 48,83,29,533/- determining the market value of land at the rate of Rs. 28/- per square feet increasing from earlier determination rate at Rs. 20/- per square feet after taking into consideration the claim of the land owner with respect to the prevailing market value of surrounding areas and other factors. Additional compensation amount as per section 40(5) of the Act of 2013 was omitted and excluded in the First Schedule as it is not applicable to the present land acquisition process since it relates to the security and strategic interests of the state;


