I would like to report that my brother namely Mr Abai Vaiphei (25) S/o Mangkeng of S. Munniam Village who was coming in his Honda Active bearing Regd No: MN8264234 from New Lamka side and moving towards Lingsihai side was hit by one speeding car i.e. Maruti 800 (red in colour) regd no: MN05A-***83 driven by unknown driver moving in the opposite direction on 14/04/2024 at around 6:00 PM near fct godown, Tualnam Village, CPUR and fled away without paying any heed, thus causing grievous injury to him and badly damaging the vehicle due to negligent driving on the part of the unknown car driver.
