Subject: First Information Report

Incident of armed robbery at State Bank of India, Salbung Branch (64016).

Sir,

With reference to the above, I would like to bring to your kind attention that there has been an incident of armed robbery at State Bank of India, Salbung Branch (64016) on 02nd May 2024 around 1:30 AM.

Four/five armed unknown individuals entered the premises of the branch. One of the individuals wore a bike helmet to cover his identity. The others wore face mask and a cap to conceal their identity. They were all armed with pistol. They took all the money at gun point from the cash counter (counter no. 02), the approximate amount being Rs 15,00,000/- (Fifteen lakh rupees). The bulk of the money belongs to SBI while a small portion of it belongs to customers who had either come to withdraw or deposit money at the branch.

They had fired a shot inside the branch manager cabin, which however misfired. They had also fired a shot outside the premises of the branch. One bullet has been recovered in front of counter No. 03, which has been handed over to the police. They had opened all drawers and searched for money.

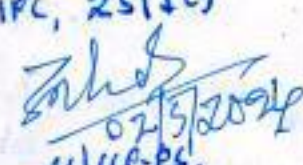
We request you to kindly investigate the incident and arrange for recovery of the missing sum of money.
