Sub.: Report on crimes of attempt to murder, use of automatic weapon and damaged of properties.

Respected Sir,

With reference to the above cited subject, I have my deepest concern to report to you as follows:

That, on the night of the 30<sup>th</sup> of April, 2024 between 10:50 PM to 11:00 PM, a group of unknown miscreants were travelling in a four-wheeler with an intent to commit an unlawful activity, on reaching the front-side of my residential house gate, they halted and fired (automatic weapon) at the gate of my residential house, which penetrated the gate and resulted in damaging my properties (mentioned below), the said miscreants committed an act with an intention to kill or an attempt to kill me and the members of my family. The damaged properties includes:

- 1) Damaging the brake line of my four wheeler, Mahindra XUV 300, bearing Regn. No. MN01 AS 2480 along with the frame of the back right Indicator.
- 2) Bullet holes on the silencer pipe of my two-wheeler, Honda Activa, bearing regn. No. A/F (newly purchased).
- 3) Damaged the gate of my residential house leaving numerous bullet holes including the front wall of my house.

That, after the incident, we recovered about 12 empty bullet shells lying on the front of my residential gate which is enclosed along with this application as an evidence of the crime scene. The situation have caused us grave mental agony especially at the hour of crisis.

The reason behind the Late filing is, heeding the advice of my family that the said unknown miscreants might approach/contact me in relation to the incident that occurred, whilst, none turned/ showed up after days of waiting, then we decided to report the said incident to the relevant authority.
