With reference to the above cited subject, I have my deepest concern to report to you as follows:

That, on the night of the 11th of April, 2024 at around 11:50 PM, a group of about 6(six) to 7(seven) unknown miscreants fully dressed in combat dress attire with face masks on, open fired at the gate of my residential house, on opening the door, they assaulted me by throwing their fists at my face in the presence of my wife.


Again, on the fateful night of the 30th of April, 2024 at around 10:45 PM, a group of unknown miscreants, suspected to be the same miscreants as mentioned above, travelling in four-wheeler, open fired (7 to 8 cartridge/bullets) with their automated weapons at my gate and left the scene.


In the given circumstances, this has been the 2nd attempt/attacked against me, my family and the family living in the same premises (sharing the same gate), and as a law abiding citizen of our nation, these follow-up unwanted criminal activities is not welcome and has caused us deep mental agony, especially to the old and young ones residing in the premise.

That, I am filing this FIR lately after having days of discussion with family & friends, since its been the 2nd (Second) attempt, we feel the need to involve the relevant authority.
