

Ten Lakh and my house, destroyed) approximately.

That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my household also set on properties, fire and The said burned unknown down my armed miscreants residential house,..... private vehicle and other household items which are given in the list enclosed along with this report.

. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate. appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

That, one namely Oinam Phajabi (O. Phajabi), aged about 42 years, W/o. Late

 Bane, a resident of Nghathal, P.O., P.S. and District Churachandpur, Manipur, presently residing at the Relief Camp of Keibul Makha Phouoibi Community Hall, Bishnupur District, Manipur had approached at this Office on the 16th April, 2024. And seeking help her to register FIR Case in connection with the present law and order situation prevailing in the State of Manipur

 That, she stated that she had fled from her home located at Nghathal, Churachandpur along with her family members on the 3rd May, 2023 due to threatened and burnt down her house along with household items by some unknown armed miscreants

suspected to be Kuki militants.

3. That, further she stated that, after fleeing from Churachandpur, she and her family members were taking shelter at the Relief Camp of Keibul Makha Phouoibi Community Hall, Bishnupur District, Manipur and in the meantime her husband was suffered illness and as such admitted at RIMS Hospital, Lamphel, Imphal. Unluckily her husband had expired at RIMS and since then she has been fallen on trauma in a tragedy life.

4. That, due to her hardship conditional problems she was unable to report at the concerned Police Station in time about the criminal acts done by some unknown armed miscreants against her family occurred on 03/05/2023 at Nghathal, Churachandpur.

That, she is a poor and helpless woman taking responsibilities of her 3(three)

children by staying at the Relief Camp stated above till now.

It is therefore requested, to kindly allow be registered FIR Case on her behalf at this delayed time if possible at an early date. Unless the FIR is being register now she shall suffer an irreparable loss and injury and she shall not entitled to get any facility or scheme from the Centre Government & State Government respectively.
