

We provide Passive Infrastructure service to various Telecom service providers licensed by the Department of Telecommunication to provide telecom network service to their customers, and as such we are filling the present grievance information.

That Indus has a ground base BTS Tower, located at village Vill Saikot PO PS Churachandpur Manipur 795128...in the premises of Mr Rev H Chungthang Theik S O Lt H T Suma R O Vill Saikot PO PS Churachandpur, Dist Churachandpur in pursuance of agreement.

On 8<sup>th</sup> April '2024 at around 1:00 AM to 3:00 AM, Some unknown miscreant have stolen the equipments installed in our site bearing Indus ID- **IN-2033410 ( CND053)**. The complete list of equipment's / assets in the above incident is as under: -
