I would like to report that on 9th May, 2024 at around 5:30 AM, my wife (X) Tingkhokim alias Semo (aged 67) was hit by Unknown driver / rider of involved vehicle in front of SBI Churachandpur Main Branch. She was evacuated to District Hospital, Churachandpur for Medical treatment and she suffered heavy casualties, with many ribs broken along with right Tibia and right fibula. Totally damaged. Unfortunately she succumbed to her injury at around 8:00 AM. It is my humble request to please catch the culprit at the earliest and ensure fair justice.
