Sir,

I, the undersigned would like to report that on the night of 02nd May, 2024 at about 06:00 PM, my son who was presently serving in Indian Army, A/No:4386372 K, Letmonlen Touthang (23) years and his peer went for some urgent matter at Tuibong Bazar, Churachandpur District. At about 06:30 PM, some unknown person, 06(six) in numbers approached my son and his peer at Tuibong Bazar, while they were buying some items at one shop. Without any known reason my son was beaten by the 06(six) unidentified persons, until he was unconscious and fled the scene and their identity, their whereabouts could not be ascertain till now.

As a result of the beating, my son received serious injuries on his right thigh contusion, both right and left fist bruises mark and chest pain, difficulty in breathing. At about 07:15 PM, I received a phone call from an unknown number telling me that my son was beaten by unknown person(s) and he is presently unconscious. I rushed to the spot and found my son lying on the ground helplessly and unconscious and quickly brought to Samaritan Hospital Churachandpur for medical treatment. But Later on, he was referred to District Hospital, Churachandpur by doctor's on duty for proper medical treatment, as my son condition was critical and was admitted and undergoing medical treatment.

In this regard, I request you to take up necessary action against the 06(six) unidentified persons as per law of the land.
