

Sir,


I have the honour to report that, I am born and brought up at D. Phailien Meitei Leikai, Churachandpur District, Manipur and living with my family of 5 members. I am a businessman by profession. On 04-05-2023 at around 10:00 a.m. some armed Chin-Kuki rioters stormed into my rented house located at D. Phailien Meitei Leikai, Churachandpur vandalized and looted all my belonging including 8 nos. of cooking gas cylinder, one license DBBL gun, some gold ornaments worth Rs. 2,00,000/- (Rupees Two lakh) and R. 10,00,000/- (Rupees Ten Lakh) in cash, land documents, registration certificates of vehicles, 5 godrej almirah, 3 beds, TV, refrigerator, washing machine, VIP Sofa and many other household items. Besides they burnt down my saw mill located at Tolnoum, Churachandpur and a garage cum store room located at Pangzol, Churachandpur including timbers worth 15 Lakhs which was kept in the said store room. It is also learnt that my, 9 (nine) vehicles i.e. 1 JCB, 2 Shaktiman, 4 TATA trucks and 2 Ashok Leyland Truck were also burnt down by unknown persons at Kamkeilon and Naphou areas, Henglep, Churachandpur District.

Fortunately, my family was rescued by A.R. personals deployed at Churachandpur and later dropped at 36th A.R. camp, Headquarter Veng, Churachandpur. The merciless and illegal act of Chin-Kuki people lead many properties belong to Meitei Community in Churachandpur including mine and disturbed the peace and tranquilities in the district.

It is therefore, requested you to kindly take up necessary action against those Chin-Kuki rioters for their illegal and brutal acts as per law.
