Sir,

I would like to report that on 03/06/2024 at around 10:30 PM my son namely David Lianminthang who is a government employee under Manipur State Power Company Limited as Junior System Assistant and on night duty at Khengjang Power Station, Khengjang, Churachandpur was attacked by one person namely, Thangjamang Kipger @ Mangcha (Contact No. 7629937153) of Khengjang Village, Churachandpur who is also an employee under Manipur State Power Company Limited alongwith some unknown associates. It is worth mentioning that this is not the first incident of such assault as my son have been a victim of assault and humiliation in the past. Also, as an evidence of an attempt to murder there is a video clip of his attacked to my son where in the video clip he was heard saying that "Ka that di hichu". Currently my son is kept under observation at Surgical Ward, District Hospital, Churachandpur for various medical examination as per doctor's advice.

Now therefore I would like to request you to take up necessary legal action against the persons involved at the earliest.
