Sir,

I am to bring to your notice that on the 3rd May 2023 at around 9:00 PM, my residence (owned/Rented) and Tea Hotel by name (Nepali Hotel) located at Torbung Bazar was attacked, destroyed and burnt by a group of Meeitei/Meiteis.

These criminals burnt down and destroyed every valuable property and important documents from my House and Tea Hotel worth Rupees 10,00,500 (Ten lakhs and five hundred) Approx. and they burnt down all the remaining things.

Therefore, with utmost respect I request you to take strong action against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code. Delay of filling an FIR is due to temporarily refuged in Kangpokpi District.
