Subject: FIR regarding physical assault and causing grievous injury

Sir,

I, Ginhaulian son of H Kapneithang residing at Zou Veng, Zenhang, Lamka would like to lodge a First Information Report (FIR) regarding an incident of physical assault that occurred at my residence.

The specifics of incident are as follows:

1. Place of incident: Hmarveng, Churachandpur, Manipur-795128
2. Time of Incident: 29th June, 2024 at around 8pm

Description of the Incident:

On the 29th June 2024 at around 08:00 PM, my friends, Minzo and Lamgoulia, came to my house accompanied by another individual, Khammawsawm (19) yrs s/o Late Kamkhenpau of Tuibong Forest Gate, Churachandpur, whom I was reluctant to welcome into my home. Despite my hesitation, Khammawsawm entered my house and an argument ensued. During the argument, Khammawsawm became violent and physically assaulted me, causing serious injury to my right hand which required immediate medical attention. I was rushed to the District Hospital where I received stitches for the wound. I have attached a copy of the medical report and the treatment received at the District Hospital.

I request you to kindly register this FIR under the appropriate sections of the Indian Penal Code (IPC) and take necessary action against Khammawsawm. I also request you to ensure my safety and provide any assistance needed during the investigation.
