

Description of the Incident:

On the 29th June 2024 at around 08:00 PM, my friends, Minzo and Lamgoulian, came to my house accompanied by another individual, Khammalsawm(19) yrs s/o Late Kamkhenpau of Tuibong Forest Gate, Churachandpur, whom I was reluctant to welcome into my home. Despite my hesitation, Khammalsawm entered my house and an argument ensued. During the argument, Khammalsawm became violent and physically assaulted me, causing serious injury to my right hand which required immediate medical attention. I was rushed to the District Hospital where I received stitches for the wound. I have attached a copy of the medical report and the treatment received at the District Hospital.

I request you to kindly register this FIR under the appropriate sections of the Indian Penal Code (IPC) and take necessary action against hammalsawm. I also request you to ensure my safety and provide any assistance needed during the investigation.
