Thangzamang (52) years s/o Nengkhai Hangshing of Zomi Colony, Churachandpur, Manipur-795128, President, United Zou Organization (UZO) General Head Quarters, Contact No. 7085201741 reported that on 4th July, 2024 at around 12:45-50 AM, Some unknown miscreants fired at the residence of Shri Chinlunthang MLA 60 Singngat AC, who is also the former president UZO Gen. Hdqtrs & present Legal Advisor of UZO Gen.Hdqtrs located at Zou Veng, Zenhang Lamka. The unknown armed miscreants fled under the cover of darkness after committing the heinous action. Some portion of the wall got damaged and 5(five) nos of empty AK-47 cartridges were later recovered at the spot. It was by dint of luck that the MLA and his family were not at home at the time of the incident as they are presently staying at Guwahati, however the grave incident has brought untold fear and anxiety upon the family. The blatant action of firing at midnight has created fear psychosis in the neighborhood thereby disturbing the erstwhile peaceful atmosphere of the locality.



In reference to the subject stated above I would like to state the following lines for your kind perusal and necessary action thereof;

1. That, in the early hours of 4<sup>th</sup> July 2024, at around 12:45-50 AM some unknown armed miscreants fired at the Residence of Shri Chinlunthang MLA -60-Singngat AC, who is also the former President UZO Gen.Hdqtrs & present Legal Advisor of UZO Gen.Hdqtrs located at Zou Veng, Zenhang Lamka.  
The unknown armed miscreants fled under the cover of darkness after committing the heinous action. Some portion of the wall got damaged and 5 (five) nos of empty AK-47 cartridges were later recovered at the spot.
2. It was by dint of luck that the MLA and his family were not at home at the time of the incident as they are presently staying at Guwahati. However, the grave incident has brought untold fear and anxiety upon the family.
3. This blatant action of firing at midnight has created fear psychosis in the neighborhood thereby disturbing the erstwhile peaceful atmosphere of the locality.

In this regard it is fervently requested that the miscreants be immediately arrested and booked as per the law of the land.
