Th Gobin Singh s/o Th, Tömcha Singh of Tera Thingbaijam Leirak , Area Manager reported that against theft of Telecom Equipment at their mobile tower location site ID UMP552 outage alarm was received in their system at the site id-UMP552(site address Mrs. Lamhoih Simte d/o Lt. Lianmang Simte , Vill- Old Gelmuol, PO + PS-CCPUR, Dist-CCPUR, State-Manipur, Pin-795128 , Cnt- 8974725278) on 11/6/2024 it was found out that some unknown miscreants had barged into the tower site and stolen away the network equipment after having broken the cabinet lock and removed from the tower with an ulterior motive of monetary gain and also disrupting the communication. Frequent unbated thefts of these kinds of equipment from their tower sites have impacted the very communication network though replacements of the equipment subject to the availability is made immediately to maintain network. It is to be mentioned here that because of huge number of thefts taking place in the circle, they are running short of such stock of equipment for replacement. Due to the ongoing conflict in manipur they were not able to file the complaint timely as their site engineer were not
