Welding machine (Dumax Make) , Grinding Machine, drilling machine, cutting machine (2 nos.) and various tools used by his masons and carpenters. The said incident probably occurred between 11:40 PM of 11/7/2024 and 03:00 AM of 12/7/2024. The approximate value of the stolen equipments are- Welding Machine- Rs. 22,000/-, Grinding Machine-Rs.2500/-, Drilling Machine- Rs. 25000/-, Cutting Machine- Rs. 2300/-, x 2= Rs. 4600/- and various tools- Rs. 5000/- ,the total of which amounts to Rs. 36,600/-. With reference to the subject captioned above, I, the undersign would like to inform you that my residential house situated at Nehru Marg, Lamka which has been under construction had been ransacked by unknown miscreant(s) on the night of 11.07.2024 (Thursday), whereby the perpetrator(s) had burglarized and stolen various construction equipments viz. welding machine (Dumex make), grinding machine, drilling machine, cutting machine (2 nos.) and various tools used by my masons and carpenters. The said incident probably occurred between 11:40 pm of 11.07.2024 and 3:00 am of 12.07.2024.

The approximate value of the stolen equipments are:- welding machine - Rs. 22,000/-, grinding machine - Rs. 2500/-, drilling machine - Rs. 2500/-, cutting machine - Rs. 2300/- x 2 = Rs. 4600/- and various tools - Rs. 5000/-, the total of which amounts to Rs. 36,600/-.

On uncovering the said incident in the morning of 12.07.2024, it has come to light that the burglar(s) climbed over the back side boundary wall of my campus and committed the offence.

After I had made several inquiries to my neighbours to get a hint of the incident, no one could provide a concrete evidence of the act.

In this regard, I hereby submitted my FIR requesting you to take immediate steps and actions so that the aforesaid perpetrator(s) may be apprehended at the earliest, and also to enable the recovery of the stolen machines and tools.
