W/SI PTDodoi, Investigating Officer of Women Police Station, Churachandpur, Manipur have submitted an enquiry report on GD Entry No:15/WPS-CCP/2024 dated:05/07/2024 to the Officer-In-Charge Women Police Station, Churachandpur, Manipur which was later forwarded to the Officer-In-Charge, Churachandpur Police Station, Manipur by Superintendent of Police, Churachandpur District, Manipur Vide Memo No: C-9/5/SP-CCP/2024/3207 Dated:19/07/2024. Stating that, Upon conducting thorough enquiry into the complaint lodged by Mr.Muan Tombing on 03/07/2024 it has been established that unknown armed miscreants numbering around 10-15 wearing mask entered his house during his absence, while his wife and daughter were present during the incident. The incident occurred on the fateful night of date 3/7/2024, which traumatized the wife and daughters of the complainant till date. During enquiry, it is also found that the mobile phone REDMI NOTE PRO 10, in the possession of his daughter bearing SIM Card No.7005868048 has been snatched by the assailants as she was caught while clicking their photographs. The same number was sent for obtaining CDR & SDR on date: 07/07/2024 for which the same has been received. While the presence of women and children during these incidents is concerning, the investigation indicates that these crimes are not specifically targeting the women members, but rather seem to be part of a border pattern of criminal

Subject: First Information Report.

- SP-CP CPT -

With references to the above cited subject, I have the honour to report to you as follows;

1. That, I am a citizen of India and a resident of Dorcas Veng, New Lamka, Churachandpur, Manipur.
2. That, at around 8:30 PM, on the 3rd of July, 2024 a heavily unknown armed group of men in full combat dress had stormed into my house located at the above mentioned address. The armed men had dragged my ailing wife on the floor as she couldn't move fast. They had also kicked and broke open our bathroom door inside which my daughter was taking bath. They had roughly treated my father-in-law at the gate of our house when he was trying to visit us. They kicked him and pushed him away and told him to go back home. Fortunately, I was not at home at that particular time. Otherwise, what would happen to me cannot be imagined.
3. That, it may also be reported here that the said armed men had snatched the Mobile phone of my daughter bearing SIM Card No. 7005868048. Hence, retrieval of my daughter's mobile would lead to the above said armed perpetrators.
4. That, it may further be reported that the said forceful activities of the heavily armed men had caused fear and grave mental agony to us and had traumatized the entire family.

In the light of the circumstances narrated above, I humbly pray you to kindly register an FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you.
