Thereafter, the Kuki people started destroying and burning the house of him resulting in all the properties were razed to the ground and all the belongings were also burned/destroyed/stoloen before burning/demolished at Khumujamba Meitei Leikai near three way IVR, under patta No. 2192/3829 and 96/Khopibung Churachandpur District,Manipur. They were rescued by armed security personal and provided shelter at a safe place in Churachandpur for the first few days. The approximate total amount of loss in Rs. 1,50,00,000/-. Cause of delay of report as he was unable to report to the police in time due to self along with his families members were taking shelter outside of manipur at Guwahati in connection with present meitei and Kuki crisis.


