

Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings were also burned/destroyed/stolen before burning/demolished at Old Bazar along Tiddim road , under Patta no. 3908, 99/Bijang Sub-Division, Churachandpur District, Manipur . We were rescued by armed security Personal and provided shelter at a safe place in Churachandpur for the first few days.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/damaging my properties and take up an FIR against them as soon as possible for the interest of justice.




