Thereafter ,the Kuki people started destroying and burning the house of him resulting in all the properties were razed to the ground and all the belongings were also burned /destroyed/stolen before burning/demolished at Khumujamba Meitei Leikai Makha along Bible hill road under patta No. 2197 (New Patta),Old Patta no. 56 and 96/Khopibung Churachandpur District,Manipur.They were rescused by armed security personal and provided shelter at a safe place in Churachandpur for the first few days. 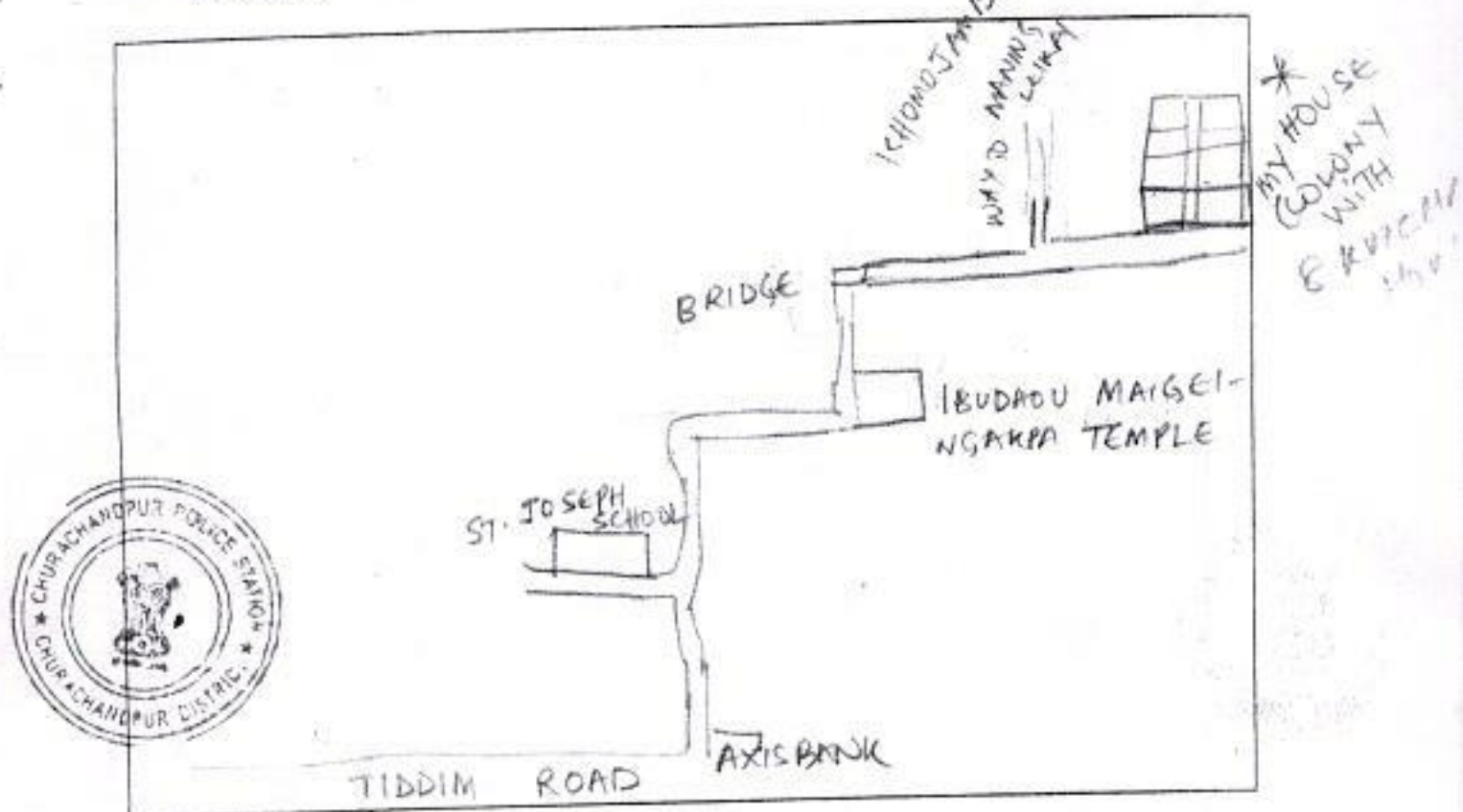
