

Thereafter, the Kuki people started destroying and burning the house of him resulting in all the properties were razed to the ground and all the belongings were also burned/destroyed/stolen before burning/demolished at Mandop Laikai ,Churachandpur District, Manipur under patta No 171(Old), 38 (New), 99/Bijang Sub-Dvision . They were rescused by armed security personal and provided shelter at a safe place in Churachandpur for the first few days. 


