With reference to SP-CCP order vide no. B-16/14/SP-CCP/2012/6455 dated 24/12/2024, a combined team comprising of Churachandpur District Police including Henglep PS, 36 Assam Rifles,NAB/CCP and Forest Department launched destruction of illegal Poppy cultivation in the Hill Range of T.Lhanghoimuol village, Henglep Sub-Division, Churachandpur, today i.e. 27/12/2024, in the presence of an Executive Magistrate.

The total area of illegal Poppy destruction is estimated to be 7 acres, which is estimated to yield 21kgs, and the value of destruction is estimated to be worth Rs. 12,60,000/- in local market. The operation started at 11:00 am and concluded at 3:00 pm of the same day.

During the operation, no arrest was made as no cultivators were found and the land owner could not be identified as it is located in the interior region. However, 5 pods of poppy plants were seized from the area of destruction after observing proper formality.

The seized articles and other necessary documents are submitted herewith for further necessary action.
