



Ningthoujam Thoiba Meetei (44) yrs s/o N.Hera Meitei of Neisel Veng(Christian Leikai) ,Churachandpur District, Manipur # 9856287324 reported that on 3/5/2023 at about 5:20 PM , some unknown persons numbering about 1000/1200 above belonging to Kuki communities started attacking him alongwith family members. Thereafter ,the Kuki people started destroying and burning the house of him resulting in all the properties were razed to the ground and all the belongings were also burned /destroyed/stolen before burning/demolished at Neisel Veng(Christian Leikai) ,Churachandpur District, Manipur under patta No. 307/5546, 99/Bijang Sub-Dvision . They were rescused by armed security personal and provided shelter at a safe place in Churachandpur for the first few days. 




