They were rescued by armed security personal and provided shelter at a safe place in Churachandpur for the first few days. 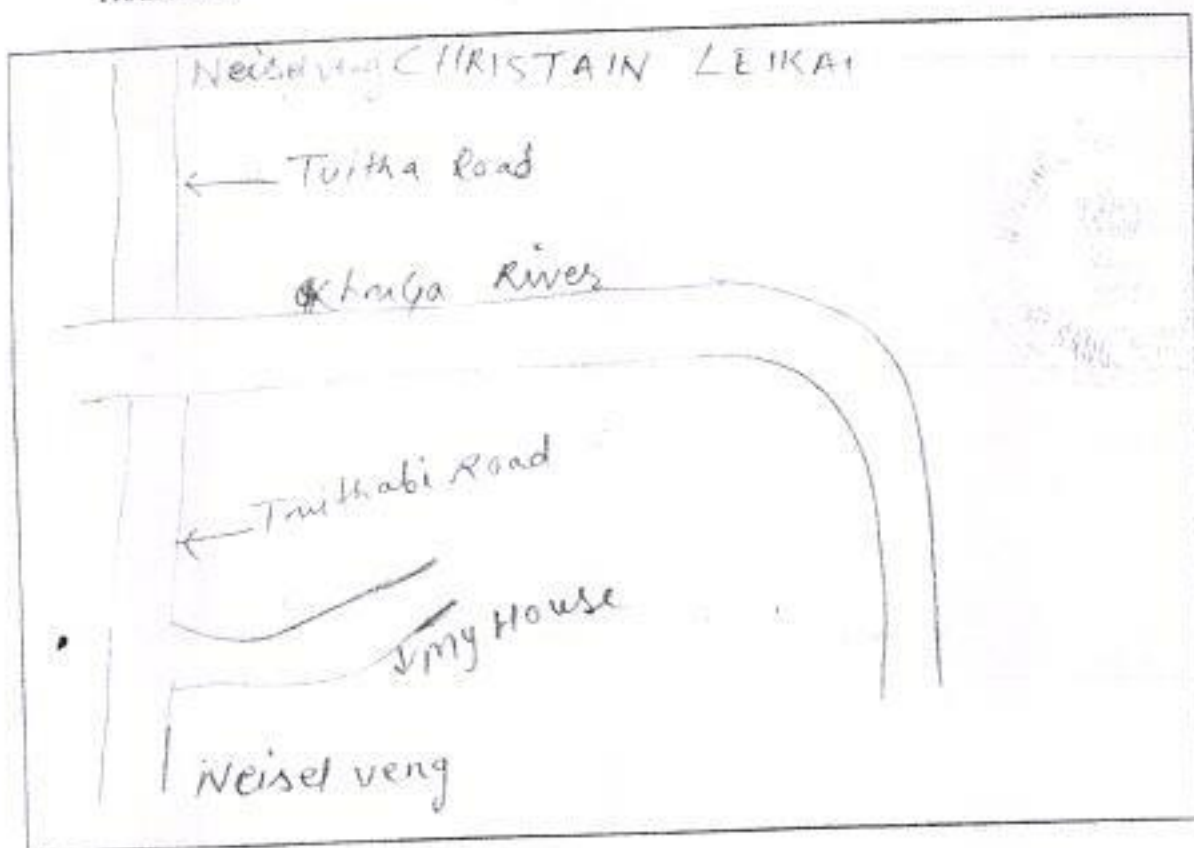
