Thereafter, the Kuki people started destroying and burning the house of her resulting in all the properties were razed to the ground and all the belongings were also burned /destroyed/stolen before burning/demolished at Old Bazar (Zelhang Bazar), Churachandpur District, Manipur under patta No. 406(Old), 301(New), 99/Bijang Sub-Dvision owner namely her husband Ningthoujam Thoiba Meetei (41) yrs s/o N.Hera Meetei. They were rescused by armed security personal and provided shelter at a safe place in Churachandpur for the first few days. 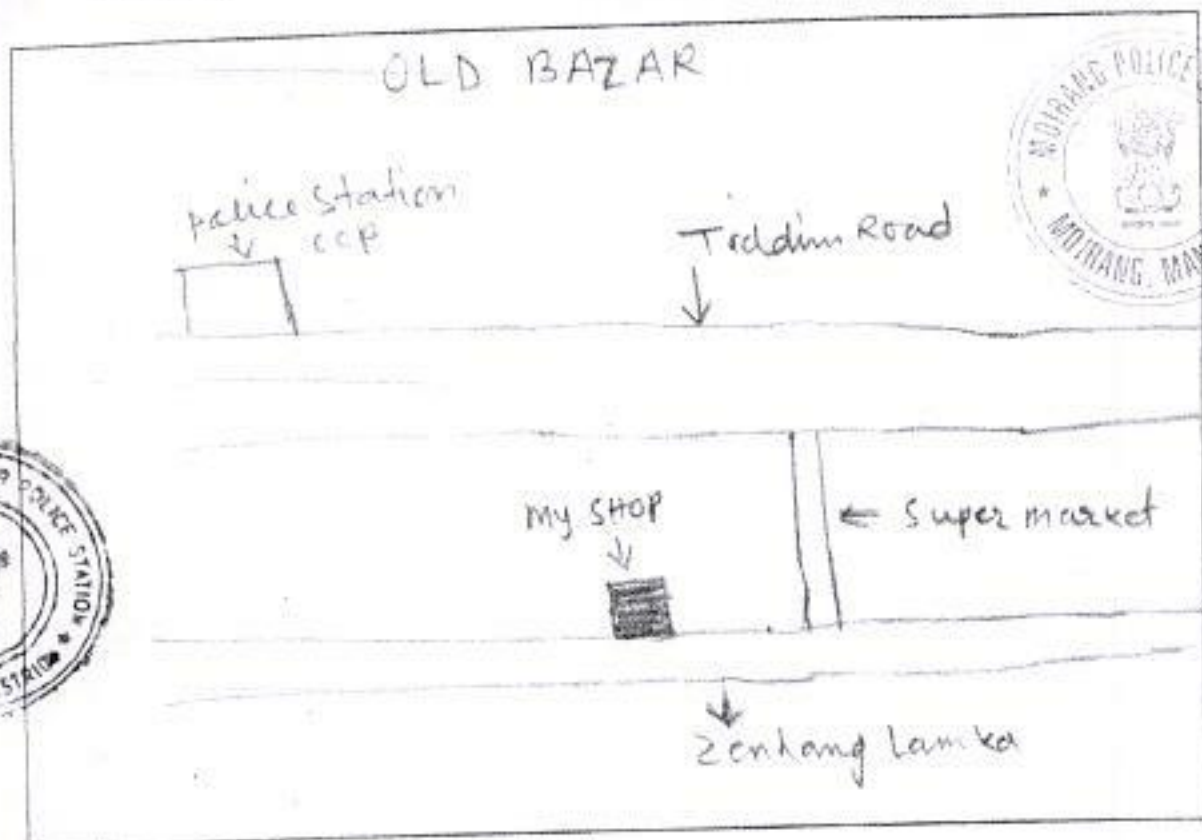

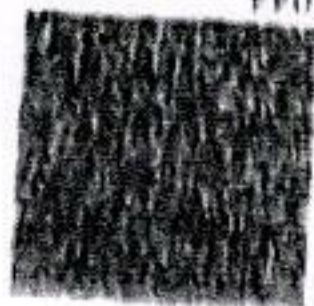
