Sir,

1. Today on 13 Aug 2024, based on receipt of specific information reliable source regarding movement of miscreants/cadres in general area saikul Ridge (Dampi Ridgeline). A search operation was launched with effect from 0400 hrs to 0830 hrs by Column of 2 MAHAR and two teams of Churachandpur Police. Detailed search of ridgeline was carried out alongwith police representatives and led to recovery of following weapons and other war like stores:-

1. One (01) X modified long range Mortal/Pompi (6 feet)
2. One (01) X modified long range Mortal/Pompi (4 feet)
3. One (01) X Single Barrel 12 bore long range gun Regn. No.71417
4. One (01) X 9mm Pistol bearing Regn. No.117414

6. Three (03) X live rounds of Pompi
7. Four (04) x live rounds of 12 bore
8. Two (02) X live rounds of 9 mm
