P Bieklien (59 yrs) s/o Late Nguldal of Chiengkongpang, CCP reported that today ie 15th Aug, 2024 at around 7:00 AM his cousin brother namely, Lalthuom Gangte (54) s/o Late Dongzalai who was living with his family at the hilltop of D Phailien Village, Churachandpur working as caretaker of the farm owned by Mr Tualzakhup of Bungmual Village, Churachandpur was attacked by unknown miscreants thereby causing grievous injury to him while he was at home alone as all family members were out at their workplace. Two large nails were drilled into his forehead and injury mark was also seen on his head. It was an attempt to murder on his cousin brother as no loss or stolen property was detected. It may also be mentioned that there is no personal enmity with others as he was ill and lying in bed for more than a year. He was immediately rushed to District Hospital, Churachandpur for medical treatment and was admitted due to his critical condition.
