A group of approximately 30 armed Kuki miscreants attacked his home, Phatthei In, at Peniel Village, Churachandpur District, Manipur, attempting to set on fire, destroy property and harm his family and others present. He suspected the involvement of the fake Thadou Tribe Council (TTC-GHQ) leaders and operative, who have made violent rhetoric and provocative statements through press release and media publications. He have attached copies of these released dated 14.08.2024 and 20.08.2024. He believe the following individuals, claiming to be leaders of the Kuki supremacist-controlled fake Thadou Tribe Council-GHQ, are either directly or indirectly responsible for the arson, attack, gun-firing, destruction, harassment, and criminal intimidation against him and his innocent family.

This is not the first incident, as his house was previously attacked on May 7, 2023 and a case was filed(FIR No.1226(08)20232 CCP-PS u/s 427/436/34 IPC, 25(1-C) A.Act). He urge prompt action to ensure their safety and security to their lives and properties.

I, T. Michael Lamjathang Haokip, a law-abiding citizen of India, am reporting a serious incident that occurred on August 25, 2024, at 10:30 pm. A group of approximately 30 armed Kuki miscreants attacked my home, Phatthei In, at Peniel Village, Churachandpur District, Manipur, attempting to set it on fire, destroy property and harm my family and others present.

I suspect the involvement of the fake Thadou Tribe Council (TTC-GHQ) leaders and operatives, who have made violent rhetoric and provocative statements through press releases and media publications. I have attached copies of these releases dated 14.08.2024 and 20.08.2024. I believe the following individuals, claiming to be leaders of the Kuki supremacists-controlled fake Thadou Tribe Council-GHQ, are either directly or indirectly responsible for the arson, attack, gun-firing, destruction, harassment, and criminal intimidation against me and my innocent family.

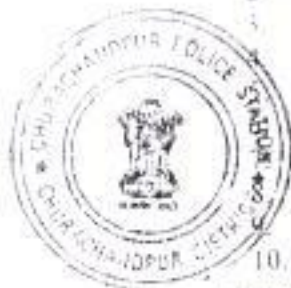

### CLARIFICATION

Therefore, the general public in general and the Thadou Tribe Community in particular is hinted by Thadou Tribe Council not to be misled by the two self styled individuals, who misused the name of Thadou for personal career building mechanism.

Thadou Tribe Council is the mainstream and affiliated to Kuki Inpi Manipur (KIM), and has been maintaining mutual co-operations and mutual respect with all sister tribe as tribes of the Kuki-Zo people, striving selflessly for the welfare of the Thadous in particular and the Kuki people in general. While Thadou Tribe Council is playing a major role to integrate all cognate tribes into onefold in full swing, it is very unfortunate to come across such misleading statements by undesigned who are not deputed to speak on behalf of Thadou people is very unfortunate, insensible, illogical, unfounded and uncalled for.

Therefore, this clarification is hereby disperse out for wider dissapating to all that Thadou Tribe Council and Thadous are one cognate Kuki tribes, which a self proclaimed Thadou Scholar and non resident citizen (NRC) who is in Australia, non deputed individual such as Jalun Haokip and Michael Lamjathang, a traitor whose house was set ablaze by angry Thadou mobs in the year 2023, misusing Thadou for their vested interest is condemnable and reprimanded not to misuse again Thadou in future. Appropriate action shall be initiated if they continued to misuse Thadou again in future.

### TTC-GHQ PRESS COMMUNIQUE

In regards to the Media Release, vide. No. nil, dated, the 4<sup>th</sup> August 2024 by 2/3 individual non-resident Indian (NRI), and who are non-bonafide Thadou, claiming to form Thadou Community International (TCI) by non-bonafide Thadou lady Chongboi married to a Foreigner, who forfeited her identity as per **'Thadou Traditions & Customary Laws'** and another **'Non-Thadou by blood'** Kapchungnung Tado, this Press Communique is hereby disseminated by the Thadou Tribe Council (TTC) GHQ, in the interest of the general public and for informations to all concerned as under.

1. That the so claimed Convenor of TCI by Non-resident Indian (NRI), non-bonafide Mrs. Chongboi, who was married to a foreigner is no longer a Thadou as per Thadou Traditions and Customary Laws, who has no says and voice to say anything on Thadou community.
2. That the so claimed Co-convenor of TCI, Mr. Kapchungnung Tado is not a Thadou by blood. As per the Geneology of Thadou, there is no such clan or clans as TADO in Thadou Geneology and society.
3. The word Tado is an online refurbished shop Tado @ <http://shop.tado.com> and another Fon State **Kingdom of Allada**, non-sovereign Monarchy within republic of Benin in Africa that existed only for 7 hours in 1967 as **Agasuvi Dynasty** (Alada-tadonu Dynasty) of the Allada Kingdom by emigrantss from Tado (1550) in the list of Rulers of the Kingdom of Allada, has no relevance, having nothing to do with Thadous of India and Myanmar.
4. That in the context of India, we the Thadous are recognised by the Government of India and Manipur state as one Sededuled Tribe (ST) in the year 1956 as THADOU, and our language as THADOU-KUKI in the year 1987 by the **'Gauhati High Court Order 12/05/1987, to the effect that the name of the dialect/ language shall hencefort be known as 'Thadou-Kuki' for the purpose of literature or Major Indian Language (MIL) subject until further orders'**, that proves we the Thadous are one among various Kuki tribes.
5. In the context of Burma/ Myanmar, according to Information from, **"South Asia and the Middle East"** (283-348), George Van Driem (2007), Christopher Moseley, London & New York: Routledge, we the Thadous are recognised as **THADO**-bearing Language Code- tez, Code Authority : ISO 639-3, Code No. 914.
6. That the non-Thadou, non-resident 2/3 individuals who hailed from the same family clan (brothers and sisters), having no space in TTC and Thadou community and Kuki society, stating the formation of

Biren Singh, the Chief Minister of Manipur, a 'Bethel Thadou Consultative 2023' held on the 21<sup>st</sup> September 2023 at Bethel village, Churachandpur elected Mr. YT Haokip as the President of TTC-GHQ, along with 29 Cabinets and Executive Members for the term 2023-2028.

That the so claimed Thadous from USA, UK, Norway, Australia, India, Myanmar, Singapore, Macau and Malaysia is funny, usurpe, unreal and irony that no Thadous staying abroad converged to form such a baseless Forum for Michael Lamjathang (whose house was burnt down by angry Thadous in 2023) and cohorts to earn money for living, and to collaborate with N. Biren Singh who waged war upon minority Kuki-Zo people where 80-85% of the victims killed and villages burnt were mostly that of the Thadous, with exceptions of Mr. Lamjathang, Mr. Nehkholal and Mr. Jalun & his sister Chongboi in Australia.

9. The 'TTC-GHQ Emergency Meeting', dated, the 19<sup>th</sup> August 2024 at resolutions No.5 (a) and (b) hereby warned non-resident 2/3 individuals playing in the name of Thadou to stop their game or else face befitting actions as deem suited to vested interest individuals playing in the name of Thadou.

10. Last, but not the least, the Thadou Tribe Council (TTC) GHQ strongly condemned the non-Thadou blood, non-residents who had frequent contact with Manipur Chief Minister, N. Biren Singh in the name of Thadou for money, at the cost of several Thadou blood, properties and land in particular and that of whole Kuki-Zo in general, in the current war, for personal gains shall be dealt accordingly.
