Subject: Request for Registration of an FIR for physical assault, intimidation and threat to life.

Sir.

On October 21, 2024 it has come to light that my niece, Miss Mongneiching Khongsai, aged about 10, daughter of Seikholen Khongsai, residing in Tuibong, Churachandpur confided her ordeal on how she was molested by Mr. Zakir, a shopkeeper nearby our house on 11th October, 2024 at around 08:00 am by covering her mouth, forcibly touched her breasts and groped her private parts and attempted to rape her by tearing her undergarment when she went to buy a hairband in his shop. She described the horrific event and showed us her torn inner wear, damaged during the assault.

I along with my family confronted the shopkeeper, leading to a public outcry. However, Mr. Thongsei Haokip, the Chief of the KNF/Zougam, sent his armed cadres to threaten us and attempted physical harm to our family. They told us that the matter would be handled by their chief. So, they took Mr. Zakir, the shopkeeper to the house of Mr. Thongsei Haokip, the chief of the KNF/Zougam. After some time, the cadres came to pick me up saying that their boss wanted to see me. When I reached the house of Mr. Thongsei Haokip, I saw Mr. Zakir sitting there. I told Mr. Thongsei Haokip that Mr. Zakir is not a person of good character. He shouted at me saying that I have to proof what I just told him. On this, at about 09:30 am (21/10/2024) around seven (7) of his cadres hit me with rifle butt and pistol on my head, while some others kicked me and slapped me shouting that I have scant regard for their boss. The KNF/Zougam cadres also forcibly switch off my mobile phone and did not allow me to comunicate with my family. I remained in their custody for about an hour. They threatened me with severe consequences including my life, if I did not comply with their dictate on the issue of Mr. Zakir, the shopkeeper who molested my niece.

In light of these serious threats against my life and my family, I urgently request the registration of an FIR under relevant sections of the law against Mr.Thongsei Haokip, the chief of the KNF/Zougam.

I, will be obliged for your kind and immediate attention to this matter involving the lives of my family and me.






