That I am temporarily resided at Ukha Tampak, PO&PS-Phaogakchauhkhai, Churachandpur District,manipur.On the 5th of August,2023 at around 4:30 AM ,My resident at Ukha Tampak was looted,Vandalized and burning down all my house and properties in to ashes by a Meitei miscreants suspected to be members of Arambai Tengol and Meitei Leepun(numbering around 500 to 1000) during this event of turmoil in Manipur.

The value of looted/Vandalism/damaged of house and properties worth around Rs. 17,14,500/- (Rupees Seventeen lakhs Fourteen thousand five hundred only).

I therefore, request you to take action against the perpetrators by registering an FIR under the relevant section of Indian Penal Code.
