I undersigned have the honour to state that, on 18/11/2024 at round 6:30 PM, my father namely Mr. Seilun Chongloi (45) Years s/o. (L) Hempao Chongloi of H.Champhai Village, PO & PS Saikul, District-Senapati, Manipur. A/P M. Songgel village, CCPur along with my mother namely Mrs. Mongneichong Chongloi (46) Years went towards Tuibong Bazaar. On the same day at 7:30 PM, at Tuibong Lemchang Junction, Churachandpur along Teddim Road, our vehicle i.e. Activa 6G B/ Regd. No. MN06SF8185 was dashed by one Car i.e. Suzuki Breeza B/Regd. No. MN02G 2612 driven by unknown person which was moving towards Imphal side in which the Activa front part was completely damaged. The accident was occurred due to rash and negligence driving on the part of the car driver. Due to the accident my father and mother got severe injuries on their persons and were rushed to District Hospital, Churachandpur for medical treatment. However, my father succumbed to his injury at District Hospital, Churachandpur and my mother was admitted at Ortho ward for further medical treatment.


