I, the undersigned would like to report that, vide SP/CCP Order No. mentioned above, combine team comprising of District Police Churachandpur, 36 Assam Rifle, NAB/Churachandpur, CCP/Forest Division and CCP-PS team launched destruction of illegal poppy cultivation in the hill range of Thinghangiang village, Tuibong Sub-Division, Churachandpur at Lat 24.344884 Long 93.569407 today i.e 14/12/24 between 9:00 am to 1:00 pm in the presence of Executive Magistrate. Total area of illegal poppy cultivation destructed was estimated to be 5.7 acres approximately. During the operation, no arrest was made and the cultivator is not known. However, 10 pieces of poppy plants bearing pods have been seized in the presence of witnesses at about 12:50 pm.

The illegal poppy cultivation destroyed is estimated to be worth Rs 39.9 Lakhs (Thirty Nine Lakhs Nine thousand) approximately, in international market.
