SI S Lialian of CCP-PS reported that on 23/12/2024 at 10:45 am received reliable information from source that an explosive have been planted under the bridge located at Leisang Village, Churachandpur. As deputed he along with a team of CCP-PS, DETT 129 QAT, C-129 Batt CRPF, 58 CRPF (Bomb Disposal Squad) and 36 AR (Bomb Disposal Squad) rushed to the spot. On reaching, a combined team cordoned off the area and stopped vehicular movement along the highway for the safety of the general public. The following explosive items were diffuse by the bomb squad and seized at the spot:

- (1) Cordex- 40 metres
- (2) Detonators (No 87 commercial)- 09
- (3) Non electrical commercial detonator- 01
- (4) Explosive (Neogel 90)- 3.6 Kgs (09xIEDs)
- (5) Safety fuse- 30 cms.


