Sir,

I would like to report that on 03/05/2023 at around 8:00 P.M. while my younger brother namely, G. David (38) s/o Thangkhanlam at Bunglemat, Cefur was returning home and passing through Thengra Leira Cefur, some stray bullets have hit his legs and other parts of his body and was seriously injured suspected to be fired by some unknown untuly Meitei mob due to the ethnic clashes between the Meiteis and the tribals. He was immediately rushed to District Hospital, Cefur for medical treatment. Due to his health condition and grievous injury he was airlifted to Kolkata and was later again transferred to Delhi and till today undergoing medical treatment at Delhi which resulted in the late report to Police Station.

In this regard I would like to request you to kindly take up necessary legal action against the Unknown untuly Meitei mob at the earliest.
