Sir,

I would like to report that on 04/05/2023 at around 5:00 PM my residential house located at Torbung Village, cclpr was attacked, vandalized, destroyed and looted by a group of unknown unruly Meitei / Maitais radicals with dangerous weapons and its properties and valuable items were stolen away. The estimate value of the vandalized, damaged, looted and stolen away properties amounts to Rs 1,66,000 (approx) and the unknown unruly Meitei / Maitais radicals were shouting anti tribal slogans while carrying out their criminal activities.

I therefore request you to kindly take up necessary legal action at the earliest. The delay in report to Police Station is due to the shifting from one place to another relief centres.
