With due respect, I the undersigned would like to a report for your kind consideration and necessary

That, as per assigned, self along with a heam of cep-ps went to Torbung-Bangla for picking up of one individual who was apprehended by Joint MVCP of Torbung Bangla for recovering arms and ammunition from his possession. On reacting, the apprehended person was identified as Liansnantal 3/0 Chinkhenmung of Pearsonmun, Lamka and the following articles were recovered by Joint MVCP from his possession: St [CCP COVY

1. 1 (one) 9mm pistol,

2. 8(Eight) dive kounds

3. 1 (one) mun Pistol Magazine

4. 1 (oue) Tear Smoke (Anti-kiol). along with the apprehended person started returning to CCP-Ps. When we reach Kaprang Village @ 12:50 pm, Domenfolks numbering around 100-150 approx. stop our relicle and demand for unconditional release of the apprehended person. In that, I directed my team to stay alert and take maximum efforts so that the apprehended person was not forcibly snatch away, by the Women folks. For some minutes, words were exchange, and

9 tried my best to convince them. Contention arises between the Police Learn and the womenfolks and tolice team also took possible measures to prevent them from forcible entry inside the vehicle. As the numbers of womenfolks keeps on increasing, our efforts to prevent them from committing unwanted forcible act becomes futile. We were outnumbered and they forcibly open the door of the vehicle and drag out the apprehended person. They also look him away and hide at an undisclosed location. On the other hand, we could prevent them from snatching the seized items and kept at the safe custody of CCP-Ps. It may also be rowth mentioning that during the incident, 9 tried numerous number of times but fail to contact my senior officers due to network problem.

9 Hurrefore, request you to hindly look into the matter and take necessary legal action against the defaulters as per the law of the land.
