Subject: Report.



Sir,

With due respect, I would like to report the unprecedented atrocities meted out against me for favour of your kind necessary action please.

That, on 03-05-2023 at around 5:00 pm, on hearing that scores of civilian sustained grievous injury following a scuffle between youths from both Kuki and Meitei community at Torbung Bazar area, Churachandpur District, PS - Churachandpur, self as a Vice-President, KSO-Henglep and a team of Henglep KSO inducted to the said place i.e. Torbung Area, Churachandpur, in a KKL Ambulance for evacuation of the injured persons.

However, on reaching Torbung Bazar, there were road blocks and as such we could not proceed further. So, I went down from the Ambulance to help the driver to make a U-turn. Suddenly, a group of Meitei miscreants poured upon me and manhandled me while the Ambulance vehicle sped away from the place. Thereon, I was brought to a nearby open space and there, I was thrashed, struck with iron rod and stick and subsequently fall on the ground as I lost my consciousness. Later, I was evacuated to District Hospital, Churachandpur for an emergency treatment.

The next day i.e. on 04-05-2023, I regained consciousness and it was that juncture, I learnt I was hospitalized with my right leg fractured and the whole of my body stained with blood bearing bruise and cut mark. Also, there were cut marks on my head that needed multiple stitch. However, after being administered extensive medical treatment for 2 months, I got discharged from Hospital for home treatment. However, despite recovering to some extent, I am still bed-ridden getting medication and regular medical check-up.

So, in light of the above facts and circumstances, I humbly request your good office to register a regular FIR so that justice is delivered to me considering the unprecedented plight and atrocities that I have endured.

Cause of delay in reporting on time is due to my medical treatment and lack of legal knowledge.
